• Headteacher Report

• Number on Roll: Stable at c200 pupils

- Attendance: Q. Year 5 attendance 92.6% why so low? A. Mainly due to unauthorised holiday absence and a persistent absentee suffering from Emotionally Based School Avoidance. Remedial actions are in place. In addition, it must be kept in mind that given pupil numbers in this year group each pupil is equal to almost 4%. We remain committed to ensuring absenteeism is well documented, regularly reviewed and immediately and robustly followed up should a trend or problem begin to emerge. Overall, looking at the School as a whole, we remain above the County and National averages.
- **Standards:** What are the targets for the current 'at expected' Year 6 cohort for Reading, Writing, GPS, Maths and RWM? And for 'greater depth'? Are there any concerns that we will fall short of any of these targets this year? If there are concerns, what interventions are in place and who has responsibility and oversight for measuring the impact of these?

Writing has the highest number of borderline pupils followed by maths. Interventions are in place to support and are being targeted on precise areas. Support provided by a combination of targeted wave 1 teaching, in class focussed groups, booster sessions for writing and maths. Interventions- responsibility with class teacher- SENCO and HT are monitoring this.

Q. Do you feel last year's cohort created a 'blip' in the school's KS2 results? How confident are we as a school that the KS2 results this year will be back to previous trends and in line/above national/Hertfordshire averages?

Current data is looking better than this time last year (SATS 2016 papers), with 73% already at ARE in reading.

Maths remains a concern, with booster sessions starting earlier. Clear focus in teaching on reasoning skill development. Writing remains a focus. Wavel teaching now uses HfL writing pilot. Initial findings are positive with improved work outcomes. Spelling is better than this time last year. Data from practice SAT in November returned strong outcomes.

- Staffing: The SENCo has resigned. Miss Matteoni, Mental Health Lead and Year 1 teacher, will take on the role of SENCo from January for two terms. The School will advertise for a SENCo to start in September. Emma Hamm will be leaving at the end of term to start a new career in the NHS. Jorja Hemmings will be leaving at the end of the term to start a new position in a neighbouring primary school. We have secured an experienced EYFS teacher from an agency to cover two terms in Reception Class from January.
- **Safeguarding Update-** All teachers had training, delivered at St. Catherine's school in Ware, on 'Grooming', led by national speaker.
- The Office Manager has completed DSL training- ensures confidential information and updates on safeguarding policies of outside clubs are monitored. In total there are 5 DSLs in the school
- Catholic Education Headteacher has attended 2 courses on the Religious Education Curriculum (to be implemented in 2025) and training received on Section 48 Inspection- disseminated to staff in October. Staff meeting on Prayer and Worship delivered by Headteacher
- Catholic Life in School The School had a Harvest Festival and donated items to Ware Foodbank, Key Stage 2 Charity Day was in the form of a Talent Contest. Money raised went to CHIPS. All classes are delivering lessons on Catholic Social Teaching. The first half term focused on Creation and the second half term on the Preferred Option for the Poor. John Birbeck from CAFOD is delivering talks to each class on CST this term.

• **Financial Review** – Overall the financial position of the School is strong. All budget heads are broadly in line with expenditure with improvement in some areas such as lower staff costs where agency costs are down slightly and conversely income from Pupil Premium income is slightly higher. The Carry Forward is now projected a healthy c£163k. having improved from the previous
